2) The gims and object and rules of the Society may be altered extended or abriged in accordance with the provisions of Section 12 & 12A of the Societies Registration Act 1860 for the time being in force.

### 3) MEMBERSHIP

- General Body: All the members of the society as mentioned in categories (above) shall form the General Body of the Society.
- MEETING OF THE GENERAL BODY: The General Body MEKKYXX shall 10) meet at least once a year, to watch the progress of the society and school functioning under the society, to guide them in their working and smooth running.
- Functions of General Body: The Secretary shall call the annual 11) meeting of the Society on any day during the first quarter of the financial year to conduct the following business:
  - a) To adopt annual report of the Secretary.
  - b) To adopt audited accounts and to pass the budget.
  - c) To Co-Opt any other member, as and when required.
  - d) To appoint Charted Accountant to audit the Accounts.
  - e) To elect the Office bearers of the Society.
  - f) To conduct any other busniss with the permission of the chair.

# 12) POWER & RESPONSIBLITY OF THE GOVERNING BODY:-

- A) To manage and control the schools.
- To invest the Money in the betterment of the Schools. C). To provide buildings premises, Furniture, equipment & books etc.

- E) To delegate its power wholly or partially in matters of appointment or dismissel of the staff to any individual of Sub-Committee.
- F) To make rules & regulations for proper management of the schoolsand to elter, amend or repeal the same.
- G) To exercise such other powers and perform such of the duties as may be necessary for the betterment of the school of execution of the objects set out in the Memorandum of the Society.
- The Society is empowered to raise loans and seek donations for the H) benifit of the schools managed by it, The Governing Body shall pas necessary resolution authorising its any two office bearers to negotiate and execute in case of loans.

#### . 13) DUTIES OF THE OFFICE BEARERS:-

To provide over all the meetings and to have a general supervision and control over all affairs of the Society. The shall be entitied to vote, and in case of tie he shall commandia Lasting vote.

Vice President: - To provide over the meetings in the absence of the President and exercise all the powers of the president after obtaining specific sanction for the same by a resolution of the Governing Body.

To keep and preerve all records of the Society and minutes of the General Body or Governing Body, and to conduct all such Correspondence relating to the Society. He will call the meeting of the Governing Body of the Socirty. He shall exercise powers of appointment removal, dismissal, discharge, leave arrangements, suspensions, Incremen with the consulation of Governing Body members of the Society in regard to the employees of the school under the management of the Society. The Secretaty is fully empowered to reply to any querry personally or in court as and when required. He can delegate his powers to any other life Member with the approval of the members of the Governing Body.

- CASHIER:- To maintain accounts of the Society and get the same audited by the Chartered Accountant.
- BANK ACCOUNTS: The Bank Account will be opened by any Nationalised Bank of India & shall be opened by any two out of the following three Office Bearers.
  - 1) President
  - 2) Secretary.
  - 3) Cashier.

- 15) <u>Meetings:</u> The Governing Body shall meet at least thrice in each year.
  - A) The Secretary shall ordinarily circulate among the members a notice of such meeting at least 3 days before the date fixed for such meeting, An Emergent meeting can be called on a short, notice, which shall not be less than 24 hours.
  - BO 50% of the members shall form the quorm of every meeting of Governing Body as well as the General Body.
  - C) Whenever there is no quorum wihin half hour's time, It shall stand adjourned, next meeting called for cannot be held for want of quorum.
  - Audit:- The Financial year shall be kept by the Secretarry.

    Audit:- The Financial year shall be counted from 1st April

The preposition shall have agreed to by the votes or three fifths of the members present at a second special meeting convened by the Governing Body at an interval of one month after the former meeting.

# Dissolution of the Society as per section 13 & 14 of S.R. Act 1860-

The peropsal to disolve the Society shall be determined by the three fifths members of the Society. In the event of any dispute arising among the said Governing Body or the Members of the Society, the adjustment of its affairs shall be referred to the Principal Court of Original Civil Jurisdiction of the district.

The dissolution shall be effected after clearing all its debts and liabilities. Any property whatsoever, the same shall abe given to some other Society & not be distributed, among the members of the Society. The General Body with three fifth Majority shall determine to which society shall be given the assets of the Society.

#### 19) Member defined as per Section-15 of S.R. Act-1860:-

A member of the Society shall be a person who having been admitted there in according to the rules regulations thereof shall have paid a subscription or shall have signed the roll or list of members therof; and shall not have resigned in accordance with such rules and regulations. The members having not been paid annual subscription or the arrears to this effect shall be disqualified from the Membership.
